SPUTES BETWEEN YOU AND LG ARISING OUT OF OR RELATING IN ANY WAY TO THIS LIMITED WARRANTY OR THE PRODUCT SHALL BE VED EXCLUSIVELY THROUGH BINDING ARBITRATION, AND NOT IN A COURT OF GENERAL JURISDICTION. BINDING ARBITRATION MEANS THAT ND LG ARE EACH WAIVING THE RIGHT TO A JURY TRIAL AND TO BRING OR PARTICIPATE IN A CLASS ACTION.

tions. For the purposes of this section, references to "LG" mean LG Electronics U.S.A., Inc., its parents, subsidiaries and affiliates, and f their officers, directors, employees, agents, beneficiaries, predecessors in interest, successors, assigns and suppliers; references to re" or "claim" shall include any dispute, claim or controversy of any kind whatsoever (whether based in contract, tort, statute, regulation, nce, fraud, misrepresentation or any other legal or equitable theory) arising out of or relating in any way to the sale, condition or nance of the product or this Limited Warranty.

of Dispute. In the event you intend to commence an arbitration proceeding, you must first notify LG in writing at least 30 days in e of initiating the arbitration by sending a letter to LG at LG Electronics, USA, Inc. Attn: Legal Department- Arbitration 1000 Sylvan glewood Cliffs 07632. You and LG agree to engage in good faith discussions in an attempt to amicably resolve your claim. The notice rovide your name, address, and telephone number; identify the product that is the subject of the claim; and describe the nature of the notice the relief being sought. If you and LG are unable to resolve the dispute within 30 days, either party may proceed to file a claim for its content of the claim for its conte

nent to Binding Arbitration and Class Action Waiver. Upon failure to resolve the dispute during the 30 day period after sending notice to LG, you and LG agree to resolve any claims between us only by binding arbitration on an individual basis, unless you opt rovided below. Any dispute between you and LG shall not be combined or consolidated with a dispute involving any other person's 's product or claim. More specifically, without limitation of the foregoing, any dispute between you and LG shall not under any ances proceed as part of a class or representative action. Instead of arbitration, either party may bring an individual action in small burt, but that small claims court action may not be brought on a class or representative basis.

**lion Rules and Procedures**. To begin arbitration of a claim, either you or LG must make a written demand for arbitration. The

rning Law. The law of the state of your residence shall govern this Limited Warranty and any disputes between us except to the extent uch law is preempted by or inconsistent with applicable federal law.

Costs. You do not need to pay any fee to begin an arbitration. Upon receipt of your written demand for arbitration, LG will promptly pay itration filing fees to the AAA unless you seek more than \$25,000 in damages, in which case the payment of these fees will be governed to AAA Rules. Except as otherwise provided for herein, LG will pay all AAA filing, administration and arbitrator fees for any arbitration ed in accordance with the AAA Rules and this arbitration provision. If you prevail in the arbitration, LG will pay your attorneys' fees keeperses as long as they are reasonable, by considering factors including, but not limited to, the purchase amount and claim amount. It it is that a foregoing, if applicable law allows for an award of reasonable attorneys' fees and expenses, an arbitrator can award them same extent that a court would. If the arbitrator finds either the substance of your claim or the relief sought in the demand is frivolous uight for an improper purpose (as measured by the standards set forth in Federal Rule of Civil Procedure 11(b)), then the payment of all ation fees will be governed by the AAA Rules. In such a situation, you agree to reimburse LG for all monies previously disbursed by it that herwise your obligation to pay under the AAA Rules. Except as otherwise provided for, LG waives any rights it may have to seek attorneys' nd expenses from you if LG prevails in the arbitration.

ings and Location. If your claim is for \$25,000 or less, you may choose to have the arbitration conducted solely on the basis of (1) nents submitted to the arbitrator, (2) through a telephonic hearing, or (3) by an in-person hearing as established by the AAA Rules. If claim exceeds \$25,000, the right to a hearing will be held at a on within the federal judicial district in which you reside unless we both agree to another location or we agree to a telephonic arbitration.

Jut. You may opt out of this dispute resolution procedure. If you opt out, neither you nor LG can require the other to participate in an ation proceeding. To opt out, you must send notice to LG no later than 30 calendar days from the date of the first consumer purchaser's ase of the product by either: (i) sending an e-mail to optout@lge.com, with the subject line: "Arbitration Opt Out" or (ii) calling 800-
